

SPECIFIC CONDITIONS :

1. No new course(s) shall be started or an ongoing course(s) shall be discontinued without the prior approval of AICTE.
2. The intake capacity in any of the approved course(s) shall not be increased or varied without the prior approval of the AICTE.
3. Adequate built up area at the approved location as per AICTE norms required for conducting Second year classes shall be ready before 31st December 2002. All infrastructural, institutional and other facilities shall be provided as per the AICTE norms prescribed from time to time.
4. No. of books, Computers & equipments should be as per AICTE Norms.
5. Teaching and other staff shall be selected according to the procedure, qualifications, experience and pay scales as prescribed by AICTE from time to time, and that they shall be paid full salaries and allowances regularly and in time.
6. The tuition and other fees shall be charged as prescribed by the State Government with in the over all criteria/limits as may be laid down by the AICTE from time to time.

7. Admissions shall be made according to the regulations and directions of the AICTE for such admissions in the respective technical institution or university.
8. The State Government policies for admissions of SC/ST, other weaker sections of Society etc. shall be followed by the Institution.
9. A separate Account in the name of the institution shall be maintained. The Accounts of the institution shall be audited by Chartered Accountant or any agency authorized by the Competent Authority and shall be open for inspection by the AICTE or any body authorized by it.
10. The Institution may be visited by an officer or a Committee of the AICTE or of its Regional Office from time to time to review the progress made by the Institution in fulfilling the conditions as laid down by the AICTE.
11. The Governing Body of the institution shall be constituted, and its Chairman shall be appointed as per the guidelines of AICTE.



SUGGESTED IMPROVEMENTS

Building (Shortfall > 10%)

- Overall built up area provided for instructional purpose, laboratory, workshop, computer center and administrative area required to be increased to meet the requirements of AICTE norms for existing courses and /or additional courses/variation in intake proposed.
- Built up area/ building provided for the academic and administrative purpose is being shared and combined with other courses need to be separated confirmed.
- The building classrooms / laboratories / workshop / computer center / library should be provided with adequate ventilation and lighting for conducive working.

Laboratories / workshops (Shortfall > 70%)

- **Laboratories:** each laboratory must be equipped with more number of sets of equipments and should replace old and out dated equipments with latest technology equipments as per syllabus and curriculum.
- **Workshop:** equipments provided in workshop should be increased to avoid overcrowding of the students. State of art and latest technology machines should be provided by replacing the out dated machines and equipments.

Computer center: (Shortfall > 60%)

- Central computing facility including departmental computer laboratories must be strengthened as per AICTE norms immediately. Relevant licensed software's as per the curriculum should be provided. Internet connectivity should be improved with higher bandwidth and more number of computers should be provided with proper networking to access Internet services. Number of peripherals must be strengthened with immediate effect.

Library (Shortfall > 70%)

- Adequate number of books with required volumes and titles, national and international technical journals and periodicals should be provided for each course/discipline and digital library must be provided.

Faculty (Shortfall > 30%)

- Permanent, university approved, regular and qualified principal must be appointed immediately
- University approved regular faculty should be appointed as per students/teacher ratio on a permanent basis w.r.t. approved intake.
- Total faculty ratio with respect to various level of faculty such as head of the department/ professor/assistant professor/lecturer should be provided in all the courses / discipline and confirmed.
- Implementation of fifth pay commission scales and allowances to teaching and non-teaching staff should be confirmed.
- The institution shall maintain proper records and rolls of acquaintance of payment and the records shall be verified by competent authorities whenever called for.

Funds

- Institution should not pay rent/transfer any amount of money/loan to the society or any institution on any account.
- Any surplus accrued out of the revenue/income of the institution should be utilized properly for development of institutional facilities.
- The institution shall incur adequate expenditure on per student training cost as per AICTE norms.
- The institution must incur appropriate expenditure as per AICTE norms on all major recurring and non-recurring items such as salary, remuneration of faculty/staff, consumables and equipments


Consequent to the Supreme Court Judgment, the Model Constitution of Governing Body notified by AICTE in its approval Regulations 1994, stands overruled. It has been decided that while AICTE will not insist on any nomination in the Governing Body of Private Unaided Institutions, the Affiliating University / State Government shall impose minimum conditions of affiliation, such as, prescription of qualifications of Governing Body Members, in order to ensure academic excellence. It shall be desirable for the private unaided institutions to induct at least 50% of the members of the Governing Body drawn from renowned academia, academic administrators, Subject Experts and professionals from industry, in order to seek their innovative ideas for continuous improvement in the delivery of teaching learning process, matching best practices elsewhere and achieve excellence.





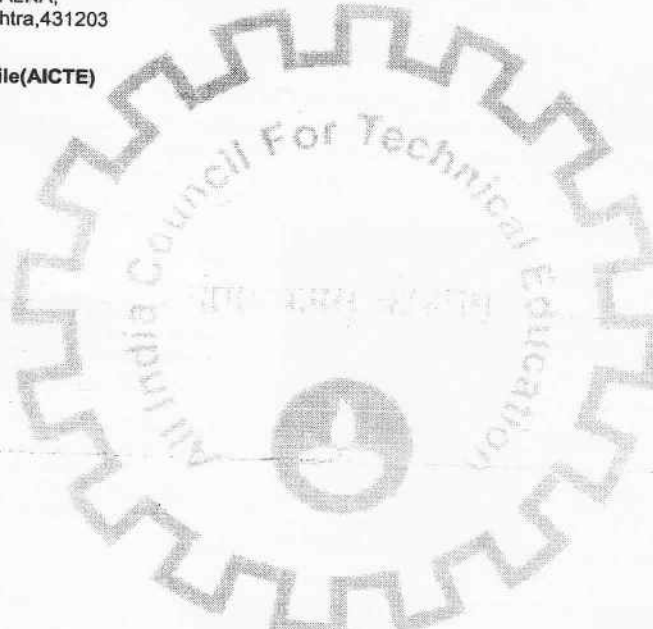
